At Bendigo on Sunday 28 June 2015, jumps jockey Tom Ryan pleaded guilty to a charge of careless riding on his mount *Yulalona* in Race 1 the *Baillieu Holst Maiden Hurdle* (3200m).

The carelessness being that after jumping the second obstacle and near the 1000m on the first occasion, he shifted in when not sufficiently clear of *Red Rossa* resulting in that gelding being tightened and having to be checked.

Mr Ryan had his licence to ride in races suspended for a period to commence at midnight on Sunday, 28 June 2015 and to expire at midnight on Saturday, 11 July 2015 – a total of 5 jumps races.

In assessing penalty Stewards took into account Tom Ryan's guilty plea and excellent record and that the carelessness was in the mid-range

A Notice of Appeal against **the severity of the penalty** was lodged on Wednesday, 1 July 2015 A stay of proceedings was not requested.

DECISION: Appeal allowed.

Penalty varied so that the period of suspension expires after the first jumps race at Gawler on 10 July 2015 (4 jumps races.)
