Carl Spry appeared on his own behalf.

At Kilmore on Tuesday, 10 November 2009, jockey Carl Spry was found guilty of a charge of careless riding on his mount *Rusky Ya Ya* in Race 5 the *Schweppes 0-62 Handicap* (1457m).

The careless riding being that approaching the 200m he permitted his mount to shift in when not sufficiently clear of *Banque Breaker*, resulting in *Banque Breaker* having to be checked to avoid *Rusky Ya Ya*'s heels.

Mr Spry had his licence to ride in races suspended for a period to commence at midnight on Tuesday, 10 November 2009 and to expire at midnight on Sunday, 15 November 2009 a total of 6 meetings (2 metropolitan, 4 provincial). In assessing penalty, Stewards took into account Mr Spry's recent good riding record and his carelessness was graded in the low range.

A Notice of Appeal against the decision was lodged on Wednesday, 11 November 2009.

A stay of proceedings was granted effective until midnight on Sunday, 15 November 2009.

CHAIRMAN: In this case the board is satisfied that the stewards' decision was correct. The fact of the matter is that there was a run there for Kane Bradley's mount and as conceded by Mr Spry today, he did not realise he was there. Had he done so, he could have taken more care to avoid the shift. In the circumstances, the appeal against conviction is dismissed.
