- A post-race veterinary examination failed to reveal any abnormalities.
- Darryl Horner Jnr pleaded guilty to a charge under the provisions of LR62(9)(a) for failing to retire his mount out of the race after it made a faulty jump at the seventh obstacle and he then continued to ride and jumped the final two obstacles when not in contention.
- No action has been taken against Al Shahn.

- The Panel agreed that Transcript was brought down by the actions of Al Shahn therefore no action has been taken.

- Waddawesinbg is no longer qualified for jumps racing and will be required to trial over a distance of at least 2800m prior to being considered for future qualification.
