### **PANEL'S COMMENTS**

- A post race veterinary examination of Fer De Lance revealed a slower than normal recovery, lacerations to both front heels and off hind bumper. No action will be taken against Fer De Lance due to the gelding's good recent form and that he was jumping well prior to losing his rider.
- Rider of So Soho, T Ryan reported the gelding jumped outwards at the majority of the obstacles and also hung out. A post race veterinary examination revealed So Soho to be lame in the near fore tendon. Trainer T OSullivan was advised that a veterinary certificate of fitness would be required prior to the gelding racing again. No further action will be taken against So Soho due to the gelding jumping satisfactorily prior to being eased out of the race.
- Rider of Abraxas, R Eynon reported the gelding was out of contention and laying out. A post race veterinary examination of Abraxas failed to reveal any obvious abnormalities. No action will be taken against Abraxas due to the gelding's good recent form and that he was jumping well prior to being eased out of the race.
