PANEL'S COMMENTS

- Rider of Danzadoozie, A Lynch reported that the gelding was jumping big and losing ground. A post race veterinary examination revealed a slower than normal recovery. Trainer S Wilde has been advised that the gelding will require a veterinary clearance prior to racing again, and will need to perform to the satisfaction of the Panel in a 2800m jumping trial.
- Rider of Legendary Lad, P Gallagher reported that the gelding never travelled or jumped well. A post race veterinary examination revealed the gelding to be lame in the left fore leg. Trainer T O'Sullivan has been advised that the gelding will require a veterinary clearance prior to racing again. T O'Sullivan advised the panel that the horse has gone for a spell and will not race again this jumping season.

PANEL'S COMMENTS

- Rider of Lake Eerie, P Gallagher reported that the gelding was not jumping well and was out of contention. A post race veterinary examination failed to reveal any obvious abnormalities. Trainer G Smith advised the Panel that the gelding would be retired from jumping racing.
- A post race veterinary examination of Traded revealed lacerations to the right front and left hind leg. Trainer A Cosgriff has been advised that the gelding will require a veterinary clearance prior to racing again. No further action will be taken against Traded as the horse was jumping well prior to falling. Future performances will be monitored.
- A post race veterinary examination of Rabbuka revealed an abrasion to the right foreleg.
