JRP FUTHER COMMENTS

- HOLLOW LOG

- A post-race veterinary examination revealed no obvious abnormalities however given the gelding fell, connections were advised they would be required to submit a veterinary certificate of fitness before Hollow Log is next presented to race.
- No action has been taken against Hollow Log and the Panel will monitor future performances.

- KOKA

- A post-race veterinary examination revealed no obvious abnormalities.
- No action was taken against Koka.

- TAKEN TIME

- A post-race veterinary examination revealed the gelding was galloped on the near hind heel and to be lame in the near hind. Trainers K&G Mayberry were advised they would be required to submit a veterinary certificate of fitness before Taken Time is next presented to race.
- Further to this Kim Mayberry advised the Panel Taken Time will not be continuing with this jumps preparation and has been sent to the paddock.

- MILLUSION BEACH

- A post-race veterinary examination revealed the mare was galloped on the off hind pastern.
- The Panel advised trainer Michael Quadara that Millusion Beach must be competitive in a jumps trial of at least 2800m prior to accepting in further races.
- Mr Quadara advised he would apply a tongue time to Millusion Beach in this trial.

- POLIXENIS BOY

- A post-race veterinary examination revealed no obvious abnormalities.
- No action has been taken against Polixenis Boy and the Panel will monitor future performances.

 - Mr McLean further advised the Panel Gold Spur pulled up sore and he will monitor his progress over the coming weeks and report back to Stewards prior to racing or trialling again.
