PANEL'S COMMENTS

- A post race veterinary examination of King of the Forest failed to reveal any obvious abnormalities.
- No action has been taken against King of the Forest and future performances will be monitored.

- A post race veterinary examination of Longshaw failed to reveal any obvious abnormalities.
- No action has been taken against Longshaw and rider Clayton Douglas has been referred to RV jumps rider coach Craig Durden.
- A post race veterinary examination of Lake Eerie failed to reveal any obvious abnormalities.
- No action has been taken against Lake Eerie as the horse was jumping well prior to being retired from the race. Future performances will be monitored.
- A post race veterinary examination of King of the Cross failed to reveal any obvious abnormalities.
- Trainer Symon Wilde was advised King of the Cross must satisfactorily complete a 2800m steeplechase trial prior to accepting in any future jumps races. Symon advised he was discussing the preference not to continue with the horse's preparation this season and will advise Racing Victoria of the decision.

PANEL'S COMMENTS

- Diello Rose when leading the field, shifted in abruptly approaching the sixth obstacle and crashed through the wing dislodging rider Darryl Horner Jnr. Approaching the second last obstacle the riderless Diello Rose again shifted in abruptly and crashed through the wing and running rail.

- The original race result recorded Diello Rose as “Fell” however after reviewing the footage the result was changed to “Ran Off”.
- Rider Darryl Horner Jnr stated that if the mare started to pull he had been instructed to allow it to stride forward which he did in the front straight on the first occasion. Diello Rose then started to race greenly and he believes this may have contributed to the horse going through the inside wing. In hindsight Darryl Horner Jnr added he may have been better to restrain the mare and race with cover.
- A post race veterinary examination of Diello Rose failed to reveal any obvious abnormalities.
- Train Eric Musgrove was advised Diello Rose must complete a satisfactory trial over 2800m prior to accepting in future races. The Panel will review the trial and assess the performance of Diello Rose.
- A post race veterinary examination of Cavallo Reigns revealed a laceration inside the mouth.
- No action has been taken against Cavallo Reigns as the horse was jumping well prior to the second last obstacle and future performances will be monitored.

PANEL'S COMMENTS

- A post race veterinary examination of Red Rossa failed to reveal any obvious abnormalities.
- No action has been taken against Red Rossa and future performances will be monitored.

- A post race veterinary examination revealed superficial abrasions to the off side hip, off hind fetlock, near fore bumper and Stewards will follow up with connections to see how the horse recovered.
- The original result of the race recorded Hezza Tidal Wave as FELL however on review of the vision the Panel changed the result to LOST RIDER.
