SECTION 6: PRIVACY COLLECTION STATEMENT

Racing Victoria Limited (ACN 096 917 930) (RV) is the Principal Racing Authority governing thoroughbred racing in Victoria, and carries out the following functions in respect of bookmakers it licenses:

- determining and issuing bookmakers' club licences;
- regulating bookmakers including monitoring compliance with licence conditions;
- monitoring bookmakers and betting transactions;
- · ensuring the integrity and probity of bookmaking businesses; and
- ensuring the efficient operation of bookmaking services.

RV is collecting your personal information on this form, including your name, contact details and financial information. We may also be collecting personal information about you which may be considered sensitive or protected under applicable laws (such information may include your criminal record (including pending civil or criminal proceedings or charges)) that you may provide in this form or under your ongoing disclosure obligations.

The purpose of collecting your personal information is for our legitimate interests, including as required pursuant to the Rules of Racing and Bookmaker Rules made under the *Racing Act 1958* (Vic), which require RV to collect information about bookmakers and betting transactions. Further, the collection of your personal information allows RV to perform its regulatory functions, including to

- make determinations in relation to your licence application, renewal or continuance; and
- meet its regulatory responsibilities in relation to you as a bookmaker.

If your personal information is not collected, either on this form or otherwise when requested by RV as part of its licensing and regulatory activities, we may not be able to process your application (and therefore refuse to grant your application or renew your licence, as the case may be) or may revoke or suspend your licence.

RV may also obtain personal (including sensitive) information about you from, or disclose your personal information to, third parties such as:

SECTION 7: PROVISION OF BETTING RECORDS

In order for RV to fulfil the Functions and Purpose described in Section 6 of this form, Rule 13.11.2 of the Club Bookmaker's License Rules 2010 (**Club Bookmakers License Rules**), a bookmaker must provide as directed by RV, all information, records or documents required by RV to verify the bookmaker's obligations under and compliance with the Bookmaker Rules and Rules of Racing made under the *Racing Act 1958* (Vic) and any relevant law, including without limitation; information regarding bets made by the bookmaker (**Betting Records**). Such Betting Records are to be provided in the form and manner as may be required by the Authorised Officer (as defined in the Club Bookmaker's License Rules).

In addition to ensuring compliance with the Club Bookmakers License Rules, Rules of Racing, the Rules of Race Betting and the Bookmaker Rules (as amended from time to time) and any relevant law, this information may be used for reporting purposes.

RV may disclose Betting Records to third parties such as:

- entities set out in section 91E of the Racing Act 1958 (Vic);
- enforcement bodies (as defined in section 6 of the *Privacy Act 1988* (Cth));
- Federal or state government authorities (for example, the Victorian Commission for Gambling and Liquor Regulation);
- racing control bodies (such as other PRA's and their equivalents in Greyhound and Harness) in the States and Territories of Australia and overseas;
- racing clubs;
- approved system providers, contractors and/or other service providers;
- · wagering service providers; and
- the Victorian Bookmakers' Association Ltd.

In making this application, we:

- (a) declare that all particulars provided in this application (including documents submitted in in support of my application) are true and correct;
- (b) acknowledge that we have read, understood and agree to be bound by the Racing Victoria Rules of Racing (**Rules of Racing**), Club Bookmakers' License Rules 2010, Bookmakers' Levy Rules 2012, Bookmakers' Telephone Betting Rules 2001, Bookmakers' Internet Betting Rules 2001 and Bookmaker Sports Betting Rules 2007 (together, the **Bookmaker Rules**), as published on the RV website, and we agree to familiarise ourselves and be bound by any amendments to those rules:
- (c) warrant that all persons whom we employ in my bookmaking business have read the Rules of Racing and the Bookmaker Rules, as published on the RV website, and:
 - (i) will assist Racing Victoria with any enquiry or direction (or other relevant matter) related to our bookmaking business;
 - (ii) Where directed or requested, will attend and give evidence in respect of any investigation or inquiry by Racing Victoria in accordance with the Rules of Racing and/or the Bookmaker Rules;
- (c) agree to be subject and bound by such rules and directions as may from time to time be made or given by the directors of Racing Victoria, the Stewards and/or betting supervisors of Racing Victoria (or any of their delegates), or any officials of any racing club registered to conduct thoroughbred racing under the Rules of Racing;

- (d) acknowledge that, when one of our Key Employees is performing the role of Approved Substitute for us, that person carries on our bookmaking business on our behalf and we are liable for the operation of that business at all times;
- (e) acknowledge that we have read and agree to be bound by the Privacy Collection Statement in Section 6 and the Provision of Betting Records in Section 7 of this Application Form;
- (f) agree to be bound by Racing Victoria policies relating to bookmakers, including the stand allocation policies, which may be amended from time to time;
- (g) agree to use an Approved Betting System (**ABS**) to record all betting activity, in accordance with Rule 13 of the Club Bookmakers' Licence Rules 2010;
- (h) agree that when using an ABS, it is our responsibility to:
 - i. conduct our own due diligence regarding the ABS provider and suitability of the ABS to our business requirements and circumstances; and
 - ii. ensure that we are satisfied with the commercial terms offered by the ABS provider including the level of insurance cover held by the ABS provider are appropriate and sufficient for our requirements and circumstances;
- (i) agree to have all outstanding payments owed to Racing Victoria (including any administrative charges, levy fees or fines) settled by the commencement of the new license period on 1 August 2018;
- (j) agree to ensure all required end of day files are transferred to Racing Victoria at the conclusion of each day of operation;
- (k) declare that we are not financially or in any other way interested in illegal betting whatsoever, and we undertake the we will not engage in any such business while we hold a Club Bookmaker's License issued by Racing Victoria;
- (I) acknowledge and confirm that, pursuant to the requirements of the *Anti-Money Laundering* and *Counter-Terrorism Financing Act* 2006 (Cth) ('**AML/CTF Act**'), we are enrolled with the Australian Transaction Reports and Analysis Centre ('**AUSTRAC**') and warrant that we are / our business is (and will continue to be throughout the period of the Club Bookmaker's Licence) compliant with our / its obligations under the AML/CTF Act;¹
- (m) warrant that as at the date of signing this declaration and at all times during the period of my Club Bookmakers Licence neither we nor our bookmaking business is in breach or contravention of or default under or non-compliance with any statute, rule regulation or bylaw whether Commonwealth or State that is related to or in connection with wagering or the activities or undertakings of operating a wagering business or the breach of which would constitute a criminal offence and neither we nor our bookmaking business has received notice that it may be in such default, contravention or breach; and
- (n) acknowledge that if this application contains any false or misleading information or conceals any material facts, our Club Bookmaker's Licence may be revoked or suspended in accordance with the Club Bookmaker's Licence Rules, and/or disciplinary action may be taken against me under the Rules of Racing.
