This application is deemed to be:

- (a) a separate application by the Company to act as a bookmaker on a Racecourse; and
- (b) separate applications by each of the shareholders and directors of the Company to permit each of them to carry on the business of bookmaking on behalf of the bookmaking Company on a Racecourse as a Bookmaker.

In making this application, we:

- (a) acknowledge that we have read, understood and agree to be bound by the Racing Victoria Rules of Racing (Rules of Racing), Club Bookmakers' License Rules 2010, Bookmakers' Levy Rules 2012, Bookmakers' Telephone Betting Rules 2001, Bookmakers' Internet Betting Rules 2001 and Bookmaker Sports Betting Rules 2007 (together, the Bookmaker Rules), as published on the RV website, and we agree to familiarise ourselves and be bound by any amendments to those rules;
- (b) warrant that all persons whom we employ in my bookmaking business have read the Rules of Racing and the Bookmaker Rules, as published on the RV website, and:
 - (i) will assist Racing Victoria with any enquiry or direction (or other relevant matter) related to our bookmaking business;
 - (ii) Where directed or requested, will attend and give evidence in respect of any investigation or inquiry by Racing Victoria in accordance with the Rules of Racing and/or the Bookmaker Rules:

- (c) agree to be subject and bound by such rules and directions as may from time to time be made or given by the directors of Racing Victoria, the Stewards and/or betting supervisors of Racing Victoria (or any of their delegates), or any officials of any racing club registered to conduct thoroughbred racing under the Rules of Racing;
- (d) acknowledge that, when one of our Key Employees is performing the role of Approved Substitute for us, that person carries on our bookmaking business on our behalf and we are liable for the operation of that business at all times;
- (e) acknowledge that we have read and agree to be bound by the Collection Statement in Section 6 of this Application Form;
- (f) agree to be bound by Racing Victoria policies relating to bookmakers, including the stand allocation policies, which may be amended from time to time;
- (g) agree to use an Approved Betting System (**ABS**) to record all betting activity, in accordance with Rule 13 of the Club Bookmakers' Licence Rules 2010;
- (h) agree that when using an ABS, it is our responsibility to:
 - i. conduct our own due diligence regarding the ABS provider and suitability of the ABS to our business requirements and circumstances; and
 - ii. ensure that we are satisfied with the commercial terms offered by the ABS provider including the level of insurance cover held by the ABS provider are appropriate and sufficient for our requirements and circumstances;
- (i) agree to have all outstanding payments owed to Racing Victoria (including any administrative charges, levy fees or fines) settled by the commencement of the new license period on 1 August 2018;
- (j) agree to ensure all required end of day files are transferred to Racing Victoria at the conclusion of each day of operation;
- (k) acknowledge and confirm that, pursuant to the requirements of the *Anti-Money Laundering* and *Counter-Terrorism Financing Act* 2006 (Cth) ('**AMLCTF Act**'), we are enrolled with the Australian Transaction Reports and Analysis Centre ('AUSTRAC') and warrant that we are / our business is (and will continue to be throughout the period of the Club Bookmaker's Licence) compliant with our / its obligations under the AML/CTF Act;¹ and
- (I) warrant that as at the date of signing this declaration and at all times during the period of my Club Bookmakers Licence neither we nor our bookmaking business is in breach or contravention of or default under or non-compliance with any statute, rule regulation or bylaw whether Commonwealth or State that is related to or in connection with wagering or the activities or undertakings of operating a wagering business or the breach of which would constitute a criminal offence and neither we nor our bookmaking business has received notice that it may be in such default, contravention or breach.

SECTION 6: COLLECTION STATEMENT

RV is the body responsible for and carries out the following functions, amongst others, in relation to the Victorian thoroughbred racing industry:

- determining and issuing bookmakers' club licences;
- supervising bookmakers;
- monitoring bookmakers and betting transactions;
- ensuring the integrity and probity of bookmaking businesses; and
- ensuring the efficient operation of bookmaking services.

Rules made under the *Racing Act 1958* require RV to collect information about bookmakers and betting transactions. In the course of performing its functions, RV will seek personal and financial information about you, directly from you and from others for the purpose of:

- making determinations in relation to your licence application, renewal or continuance; and
- meeting its supervisory responsibilities in relation to you as a bookmaker.

The personal and financial information collected by RV will be kept on a confidential basis, but may be disclosed to third parties in connection with RV's supervisory and management functions and in the interests of the integrity and probity of the racing industry. For example, personal information may be collected from or disclosed to, amongst others:

- enforcement bodies (as defined in section 6 of the Privacy Act 1988 (Cth));
- State Government licensing authorities (for example, the Victorian Commission for Gambling Regulation);
- racing control bodies in the States and Territories of Australia;
- racing clubs; and
- The Victorian Bookmakers' Association Ltd.

Should you decline to provide personal and financial information to RV when requested by RV as part of its functions, RV may refuse to grant or renew a licence or may revoke or suspend your licence.

You may make a request to RV to gain access to your personal information held by RV. A fee may apply. Requests are to be made in writing, to RV's Privacy Officer:
