This form will enable Racing Victoria to make an assessment as to whether they will issue you a Club Bookmaker's Licence.

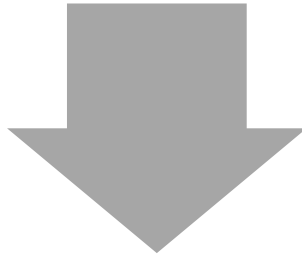
In Victoria operating as a lawful bookmaker requires a **two-step** process:

1. BOOKMAKER REGISTRATION AND GUARANTEE

A person applies to the Victorian Gambling and Casino Control Commission (VGCCC) to become "registered" as a bookmaker.*

As part of that registration process, the person must have a **guarantee** which meets the requirements of section 94A of the *Racing Act 1958* (Vic).

This can be accomplished in two ways: (1) become a member of the Victorian Bookmakers' Association and contribute to their guarantee fund; (2) make alternative arrangements with the VGCCC.



2. BOOKMAKER LICENCE

A registered bookmaker then applies to Racing Victoria, as a principal racing authority, to enable them to lawfully commence bookmaking operations.

"Approved Substitute" means a Registered Bookmaker's Key Employee who has been approved by Racing Victoria pursuant to section 91AB of the Racing Act and Licence Rule 9 to carry on the business of a bookmaker during a period of absence by the Bookmaker.

"Bookmaker Rules" means the *Club Bookmakers' Licence Rules, Bookmakers' Levy Rules 2012, Bookmakers' Telephone Betting Rules 2001* and *Bookmakers' Internet Betting Rules 2001* as published on the [RV website](#),

"Key Employee" means the holder of a current certificate of registration as a Registered Bookmaker's Key Employee under Part 5A of Chapter 4 of the Gambling Regulation Act.

"Metropolitan" racing venue means a race meeting conducted at Flemington, Caulfield, Sandown or Moonee Valley, or select meetings at Mornington and Bendigo.

"Rules of Racing" means the Racing Victoria Rules of Racing (including the Rules of Race Betting) as published on the [RV website](#),

"Terms and Conditions" means the terms and conditions and betting rules which apply to an account, as agreed between the Bookmaker and a client, and as described in Rule 16.7 of the *Club Bookmaker's Licence Rules*.

- (c) if the Applicant is a natural person, a person who is a Relative of the Applicant.

Stand allocations will be based on your selections on this Application and allocations will be made in accordance with [Racing Victoria's Victorian Bookmakers' Policies](#). Tick each venue you wish to be considered for - please be careful to complete your selections correctly.

- regulating bookmakers including monitoring compliance with licence conditions;
- monitoring bookmakers and betting transactions;
- ensuring the integrity and probity of bookmaking businesses; and
- ensuring the efficient operation of bookmaking services.

RV is collecting your personal information on this form, including your name, contact details and financial information. We may also be collecting personal information about you which may be considered sensitive or protected under applicable laws (such information may include your criminal record (including pending civil or criminal proceedings or charges)) that you may provide in this form or under your ongoing disclosure obligations.
