Purpose

This guide has been prepared to assist Approved WSPs in understanding the reporting requirements under Racing Victoria's standard conditions of approval to publish and use Victorian thoroughbred race fields (**Standard Conditions of Approval**).

Capitalised terms used in this guide have the meaning given in the Standard Conditions of Approval.

In addition, the following terms are used in this guide:

Event Date means the date on which a Victorian Race which is the subject of a Betting Transaction occurred.

Result Date means the date on which the Betting Transaction resulted (that is either won or failed).

Introduction to the Race Fields Policy 2023/24

If Aggregated Assessable Turnover is greater than the Turnover Threshold, and Aggregated Assessable Revenue (ex GST) is greater than the Gross Revenue Threshold, a levy is applied based on Bet Type and the type of Race Meeting as per Table 1.0 below.

For FY 2023/24 the Turnover Threshold is \$5 million (Turnover Threshold is not applied to Betting Exchange), and the Gross Revenue Threshold is \$500k.

Guide to Daily Supply of Data

1. Requirement under Standard Conditions of Approval

Clause 3.4.3 and 3.4.4 of the Standard Conditions of Approval requires each Approved WSP to:

3.4.3: provide to RVL in the media (hard copy or electronic), by the method and at the time or times requested by RVL, all information relating to Betting Transactions (including amounts paid to Customers in relation to those Betting Transactions, Bet Backs and Free Bets) on a race-by-race, venue-by-venue and day-by-day basis in the form annexed to these conditions and available for downloading on the RVL website (as that form is amended by RVL from time to time).

2. Daily Data Collection

Racing Victoria requires a daily file (**Daily File**) containing details of all Betting Transactions which have the same Result Date to be submitted by 9am on the following day. Racing Victoria anticipates that Approved WSPs will automate this process and submit to Racing Victoria overnight via FTP.

The naming convention for the Daily Files is:

WSPxxxxx_DDMMYYYY.csv

Where:

- xxxxx is the Approved WSP Unique Code (provided to Approved WSPs by Racing Victoria); and
- DDMMYYYY is the Result Date within the file.

Example file name: WSP10001 01082014.csv

3. Monthly Data Submission (if applicable)

A WSP must submit a monthly data file, which is in the same format as the daily file, if there is any adjustment in the details of the betting transactions that are resulted in the same monthly payment period. This monthly file must be submitted to RVL via FTP within the first three days after the end of each payment period. For example, a WSP should submit the November 2023 monthly data file by 3rd December 2023.

4. Introduction to the Data Collection

A sample of the Daily File is Attachment 2.

Data should be supplied in a comma-separated values (CSV) format and otherwise as follows:

Not all headings are relevant to each Approved WSP, however it is important that Daily Files submitted include a column for each of the elements listed. Nil values should be populated as zero.

4. Definitions

Please refer to the Standard Conditions of Approval for Definitions of all terms.

4.1 Venue Code

A list of official Racing Australia venue codes has been included as Appendix B.

4.2 Bets Taken

Bets Taken includes Betting Transactions involving single or multiple contingencies, all of which resulted at a Race Meeting. This includes but is not limited to Win, Place, Trifecta, Exacta, Quinella, First Four, Head-to-Head, Margin bets and any other approved race-specific bet types.

For the purposes of the Daily File, where a Betting Transaction relates to more than one Victorian Race occurring at the same Race Meeting, the amount of the Betting Transaction is apportioned evenly across each of the Victorian Races which are the subject of the Betting Transaction.

Any Betting Transaction involving multiple contingencies across more than one Race Meeting or events are to be excluded from Bets Taken and treated according to the rules set out in the Standard Conditions of Approval for Multi-Event/Multi-Leg Bets.

No deductions are permitted for money back offers or similar inducements in relation to non-winning Betting Transactions.

4.3 Tote Derivative

Tote Derivative means a Betting Transaction in respect of which the odds provided or quoted by the Approved WSP are derived from or calculated or expressed by reference to Totalisator Odds.

4.4 Free Bets Taken

Bets Taken includes all Free Bets.

4.5 Free Bets Paid

Bets Paid does not include Free Bets Paid.

5. Daily Reporting of the Eligible Portion of a Multi-Event/Multi-Leg Bet

Approved WSPs are required to report on the Eligible Portion of a Multi-Event/Multi-Leg Bet that resulted on the Result Date which is reported on in the Daily File.

The face value of a Multi-Event/Multi-Leg Bet is apportioned equally across the legs and the Eligible Portion of a Multi-Event/Multi-Leg Bet which is reported in the Daily File is the proportion relating to Victorian Races on the Result Date.

Example 5.1

An Approved WSP accepts a \$75 Multi-Event/Multi-Leg Bet for the AFL Grand Final (27/09/2014) into an ATP Tour Event into the Cox Plate, (25/10/2014). The bet results on the Cox Plate.

This bet would be split into three portions. The requirement is to report only the Victorian Racing portion:

6. Reporting Eligible Portion of Winning Multi-Event/Multi-Leg Bet (EPWMB)

Approved WSPs have a choice of method for calculating the Eligible Portion of a Winning Multi-Event/Multi-Leg Bet.

An Approved WSP may elect to calculate Eligible Winning Portion as either:

(a) the amount paid or credited to a Customer under the Multi-Event/Multi-Leg $\times \frac{VRO}{AO}$ Bet

where:

VRO means the odds set by the Approved WSP under the Multi-Event/Multi-Leg Bet for the Relevant Winning Race; and **AO** means the sum of the odds set by the Approved WSP for all legs of the Multi-Event/Multi-Leg Bet; or

(b) the amount paid or credited to a Customer under the Multi-Event/Multi-Leg Bet $\times \frac{1}{AC}$

where **AC** means the number of contingencies within the Multi-Event/Multi-Leg Bet.

Approved WSPs must notify Racing Victoria in writing of the nominated calculation method prior to the commencement of the Approval Period. Once the Approved WSP has notified Racing Victoria of its nominated calculation method, the Approved WSP may not alter its nomination method within the Approval Period.

Example 6.1

An Approved WSP accepts a \$50 Multi-Event/Multi-Leg Bet in the Caulfield Cup into the Melbourne Cup. The bet is successful on the Melbourne Cup.

Example 6.1 - Option a)

Stake = \$50

Event Odds = \$5.25 for Caulfield Cup; \$12.00 for Melbourne Cup

Step One: Calculate Total Odds = $$5.25 \times $12.00 = 63.00

Step Two: Calculate Sum of All Odds = \$5.25 + \$12.00 = \$17.25

Option a) EPWMB = (Stake x Total Odds) x (Event Odds / Sum of All Odds)

Option a) EPWMB Caulfield = $(\$50 \times \$63) \times (\$5.25/\$17.25) = \$958.70$

Option a) EPWMB Flemington = $(\$50 \times \$63) \times (\$12.00/\$17.25) = \$2,191.30$

Option a) Sum of EPWMB (across both legs) = \$958.70 + 2,191.30 = \$3,150.00

Example 6.1 - Option b)

Stake = \$50

Step One: Calculate Total Odds = \$5.25 x \$12.00 = \$63.00

Option b) EPWMB = (Stake x Total Odds) x (1 / Total Number of Contingencies)

Option b) EPWMB Caulfield = $(\$50 \times \$63) \times (1/2) = \$1,575.00$

Option b) EPWMB Flemington = $(\$50 \times \$63) \times (1/2) = \$1,575.00$

Option b) Sum of EPWMB (across both legs) = 1,575.00 + 1,575.00 = \$3,150.00

Example 6.2

An Approved WSP accepts a \$75 three-leg Multi-Event/Multi-Leg Bet featuring Sport and Victorian Racing (AFL, tennis and the Cox Plate). The Betting Transaction results on the Cox Plate. The Approved WSP reports only the relevant Victorian Racing portion.

Example 6.2 - Option a)

Stake = \$75

Event Odds = \$3.80 for Cox Plate runner; \$1.25 (Tennis); \$1.40 (AFL)

Step One: Calculate Total Odds = $$1.25 \times $1.40 \times $3.80 = 6.65

Step Two: Calculate Sum of All Odds = \$1.25 + \$1.40 + \$3.80 = \$6.45

Option a) EPWMB = (Stake x Total Odds) x (Event Odds / Sum of All Odds)

Option a) EPWMB Cox Plate = $(\$75 \times \$6.65) \times (\$3.80/\$6.45) = \$293.84$

Example 6.2 - Option b)

Stake = \$75

Step One: Calculate Total Odds = \$1.25 x \$1.40 x \$3.80 = \$6.65

Option b) EPWMB = (Stake x Total Odds) x (1 / Total Number of Contingencies)

Option b) EPWMB Cox Plate = $(\$75 \times \$6.65) \times (1/2) = \$166.25$

7. Count of Bets

A count of the number of bets placed on Victorian Thoroughbred Racing, per race. Where applicable, this should be populated for both pari-mutuel and non pari-mutuel bet types. The eligible portion of a multi bet shall be recorded as:

(a)
$$\frac{VR}{A}$$

where:

VR means the number of contingencies related to Victorian Racing; and

A means the total number of contingencies within the Multi-Event/Multi-Leg Bet.

8. Count of Clients

A count of the number of clients to have placed a bet on Victorian Thoroughbred Racing. Where applicable, this should be populated for both pari-mutuel and non pari-mutuel bet types. The total number of unique clients is an aggregation across bet types (ensuring no client is counted twice within each bet type category).

The YTD number of unique clients is a rolling aggregation since July 1st.

Ideally this would also be calculated at race level, however for simplicity this can be repeated across each race as YTD count for that meeting.

9. Count of New Clients

A count of the number of clients to have placed their first bet on Victorian Thoroughbred Racing (irrespective of a client's first bet date).

For example, a client joins a WSP in March, (related to an NRL promotion). This client bets on NRL matches across March and places their first bet on Victorian Thoroughbred Racing in April. In this example the client would be reported (at race level), as a new client for Vic racing in April.

10. Turnover by Channel

Turnover must be included (at race level), by channel. Mobile via mobile sites and apps should be distinct from turnover via the primary internet site and turnover via a contact centre. If applicable, also nominate turnover via retail, licensed venues and on-course. Not all categories will be applicable to each WSP, therefore null values should be populated with a zero value.
